



PRIVACY POLICY

pursuant to Article 13 of EU Regulation 2016/679 (GDPR) Spring Cup - Palasesto, 14-16 February 2025

Dear Participant,

The Data Controller, **Associazione Sportiva Dilettantistica PRECISION SKATING MILANO**, hereby informs you that participation in the international synchronised skating competition *Spring Cup 2025* will entail the processing of personal data of participants (athletes, coaches, teams, audience, etc.), such as, for example, personal details and affiliation with sports clubs/associations, as well as images captured through photography and video recordings during the event. The use of such personal data is inherent to the sporting and public nature of the competition, its organisational requirements, and the provision of related services to participants. The ASD will process personal data, including through its collaborators, volunteers, and technical and service partners, for the following primary purposes:

- Verification of eligibility to participate in the competition, including administrative, organisational, and logistical aspects related to the event, such as processing personal data necessary for participant reception and registration, issuance of identification badges, and provision of information, support, and assistance services to registrants (*legal basis: Article 6(1)(b) GDPR*);
- Communications necessary for the conduct of the competition to sports and public authorities (e.g., FISG Italian Ice Sports Federation) (*legal basis: Article 6(1)(c) GDPR*);
- Safeguarding the vital interests of participants in the event that medical assistance services become necessary during the competition (*legal basis: Article 6(1)(d) GDPR*);
- **Documenting the event**, based on the **legitimate interest** of the Data Controller, through the dissemination of photographic images or audio-video recordings collected during the event via the website, associated social media channels, or any other means of publication (e.g., brochures, publications, etc.) (*legal basis: Article 6(1)(f) GDPR and Article 97 of the Italian Copyright Law*).

The Data Controller wishes to draw the attention of all participants to the fact that accredited photographers and videographers will be capturing images throughout the event for the specific purpose of documenting the competition on the ASD's official website (https://www.hotshivers.it) and the Spring Cup website (https://www.springcup.it), as well as on all related social media platforms (Instagram, Facebook, TikTok, etc.). Photographs will be made available to participants for private use, either free of charge or for purchase. Additionally, video recordings may be managed directly by **FISG (FisgTV)**, to which reference should be made for further details regarding the processing of personal data (https://figura.fisg.tv).

The processing of personal data may be carried out using paper-based and/or electronic means, in compliance with applicable laws and in accordance with the principles of fairness, lawfulness, transparency, and confidentiality. The ASD undertakes not to use images in any manner that could be detrimental to the dignity, reputation, or decorum of the individuals portrayed. The aforementioned photographic and audio-video materials may be retained in the ASD's archives as part of the historical record of its events, institutional activities, and competitive achievements.

At any time, you may exercise the rights granted under Articles 15-22 of the **EU Regulation**, including **the right to object to the use of your image** (for further information, please refer to https://www.garanteprivacy.it/web/garante-privacy-en/home_en). The provision of personal data for the purposes outlined above is essential for participation in the event. Any objection to the photographing or recording of an athlete may result in the inability to capture images of the entire team.
